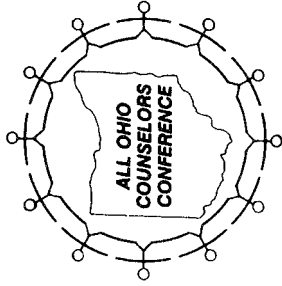

At this time we invite you to share your expertise and experience by submitting a presentation proposal. Based upon feedback from past attendees, we are actively seeking proposals for sessions with engaging practices that can be easily implemented into one's professional practice. Proposals with either a focus at the beginner level (material for new counselors or counselors developing a new specialty area) or the advanced level (material for more experienced counselors) are encouraged. When submitting your proposal, you will have the option of selecting either a 60 or a 90- minute session length. (Not sure if you have the knowledge or expertise to present? Check out the on-line submission form for an extensive list of presentation topics. You might just see something that sparks your creativity.)

Presenters at the All Ohio Counselors Conference must be a member of either the Ohio Counseling Association or the Ohio School Counselor Association. If there are multiple presenters, the lead presenter must be an active member of OCA or OSCA. The deadline for proposal submission is 5:00 p.m. on Friday, May 14, 2010. Should your proposal be selected for presentation, you will receive one complimentary conference registration. Co-presenters, if any, are required to pay the full registration fee. Pre- and post-conferences and meal costs are not included in the complimentary registration, therefore, if you plan to attend any of these events you must pay for them separately.
