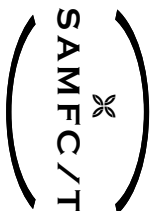

From the South: Take I-77 North to Route 8. Take the University of Akron exit marked Buchtel/Carroll St. Turn left onto Buchtel, then right onto Fir Hill St.

From the East: Take I-76 West to Akron. Take the right fork off I-76 West to Rt. 8 North. Take the first exit off Route 8, Buchtel/Carroll St. Turn left onto Buchtel, followed by a right on to Fir Hill Street..

From the North, taking I-77 South: Exit onto Wolf Ledges/Grant St. Turn left at the first light onto Wolf Ledges, or left at the second light onto Grant St. Turn right onto Exchange St., right onto Spicer St., left onto Buchtel, right onto Fir Hill St..

From the North, taking Route 8: Exit at Perkins St. Turn right, then left onto Union St. Proceed to Buchtel Ave.

From the West, taking I-76 East: Exit onto Wolf Ledges/Grant St. Turn left at the first light onto Wolf Ledges, or left at the second light onto Grant St. Turn right onto Exchange St. right onto Spicer St., left onto Buchtel, right onto Fir Hill St..
