Therapist/Community Wellness Specialist (Part-Time)

Columbus College of Art & Design prepares tomorrow's creative leaders for professional careers. The college includes BFA and MFA degree programs.

The Columbus College of Art & Design's Counseling & Wellness Center (CWC) is seeking an energetic and creative mental health professional to fill the role of Therapist/Community Wellness Specialist. This position reports to the Director of the Counseling & Wellness Center, and serves as a member of a collaborative team who provides high-quality mental health and wellness services to CCAD students, including: individual and group therapy, crisis intervention and consultation, development and implementation of wellness and prevention education campaigns and programs, and design and delivery of educational seminars and trainings.

Description of responsibilities and duties:

- Provide individual and group therapy for students consistent with CWC's scope and mission
- Provide intake, triage, and staff regularly scheduled urgent walk-in hours
- Periodically serve in an on-call capacity as back-up to Director for afterhours crisis intervention and consultation
- Consult with faculty, staff, parents, and students with regard to student mental health or behavioral concerns
- Design and implement wellness education and outreach programming to address student needs
- Collaborate interdepartmentally to orchestrate population-based prevention and wellness promotion initiatives
- Assist Director in administrative functions of the CWC as needed, and attend regular clinical team meetings
- Complete all clinical documentation within the electronic documentation system in accordance with CWC policy
- Approximate division of responsibilities will include direct service (75%), wellness education and outreach (15%), administration (10%)

Qualified applicants:

- Have completed at least a master's level program in a mental health field
- Are licensed in good standing as a professional counselor, social worker, or psychologist in the state of Ohio
- Carry their own professional liability insurance coverage
- Have experience working with diverse clients in individual and group settings
- Are highly relatable with college students in therapeutic and programmatic contexts
- Have experience delivering engaging and innovative outreach and wellness programming
- Demonstrate a record of teamwork and creativity
- Evidence strong crisis assessment and intervention skills
- Are self-motivated and able to work within flexible and fast-paced environments

Preferred qualities:

- Independently licensed as an LPCC, LISW, or psychologist
- Experience working in a collegiate setting
- Expertise in the treatment of trauma-related concerns
- Experience working with sexuality or gender spectrum variant clients
- Competence in multicultural or international student work

Contract and compensation:

This is a part-time, contracted position, active while school is in session (August-May, excluding breaks) with some schedule flexibility. Compensation is \$40 per hour. Heath insurance and other benefits are not provided through this position. Continued employment is contingent upon review and renewal of contract on an annual basis.
