If driving from the North, Taking I-77: Follow the signs for I-77 South to Wolf Ledges/Grant Street exit (Exit #22B). Turn left onto Wolf Ledges and follow until street curves toward right and becomes Carroll Street. Proceed past College of Nursing building and park in Lot #36 or Exchange Parking Deck. Student Union Building is next building (red brick) on Carroll Street.

If driving from the North, taking Route 8: Follow Route 8 South to I-77 North, take Wolf Ledges/Grant Street exit (Exit #22B). Go Straight. Turn right at second light (Wolf Ledges) and follow until street curves toward right and becomes Carroll Street. Proceed past College of Nursing building and park in Lot #36 or Exchange Parking Deck. Student Union Building is next building (red brick) on Carroll Street.

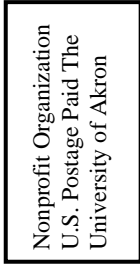

Workshop Description: This workshop is meant to increase a practitioner's knowledge of trauma in the specific areas of treatment, ethics, and multiculturalism. Through lecture, question/answer periods, and discussion, this workshop will provide an overview of specific interventions to use with individuals who have experienced trauma. Ethical and legal issues will be presented that may arise when family violence occurs to help counselors manage boundaries and navigate the legal system. A panel discussion consisting of representatives from community agencies will help inform participants in the ways in which they can respond to unique populations who have experienced trauma.

Workshop Objectives: Participants will become familiar with the principles, tools, and techniques of Trauma Focused-CBT with children and adults. Additionally, participants will learn about the legal and ethical issues regarding family violence and how to respond to the needs of diverse populations who experience trauma.
