Workshop Description

This workshop is intended for counseling students, new counseling professionals, and all counselors who want to make a positive difference in the lives of their clients. Participants will identify strategies through informal and/ or formal advocacy/leadership opportunities to enhance client care. Participants will learn from a variety of counselors who have exhibited leadership and advocacy through administration benefiting clients and the counseling profession. The panel will showcase practicing counselors who demonstrate leadership on a daily basis through counseling, supervision, administration and professional service to advocate for their needs of clients. Presenters will provide examples successes and challenges (e.g., ethical issues) of how their clinical decisions has influenced their practices and treatment of clients. Lessons shared by presenters will be applicable to counselors in: Addiction Counseling, Clinical Mental Health Counseling, School Counseling, Student Affairs & College Counseling, and Counselor Education.

Objectives

- 1. Participants will understand the necessity and expression of leadership in service delivery (e.g., clinical supervision, client advocacy, program coordination) and the ethical issues involved to enhance client care.
- Participants will learn ways client advocacy can be expressed in a variety of counseling settings (e.g., Addiction, Clinical Mental Health, School, Student Affairs & College) with specific examples of how it has improved client care.
- 3. Participants will identify counselor knowledge and skills that contribute to their ability to advocate/lead individual / system wide change for clients through counseling, supervision, administration, professional service that has improved the wellbeing of clients in their current counseling setting.

Counseling students are encouraged to submit a poster proposal (literature review or research) on a variety of counseling areas. We also encourage submissions to address leadership (e.g., supervision, counselor education) and/or advocacy (e.g., client, profession) issues.
