### Report on the May 19, 2009 "Engagements and Actions for Public Retirement Systems," Sponsored by the Ohio Council of Higher Education Retirees (OCHER)

Present were eighty-seven individuals from ten of the eleven Ohio four-year universities, along with representatives of five professional associations and four pension systems including the Illinois State Universities Annuitants Association. The Conference began at 9:30 AM and finished at 3:15 PM. There were two keynote speeches in the morning focusing on coalitions among state pension systems and the economic effectiveness of defined benefit pension systems. In the afternoon, two panel discussions focused on pension system concerns at the national level and pension system concerns in Ohio especially compared with the Illinois University retirement system. This report will focus on the highlights of the first of the two keynote addresses. A more detailed account of the other address and the panels will be sent to members of the Emeriti Association listsery.

■ Assets: \$41,670.17 ■ Membership: 321 Terri Bierdeman, Director of Governmental Relations for STRS, delivered one of two key-note addresses describing the work and organization of "National Coalitions of State Pension Systems." Bierderman emphasized: 1. That a few letters to elected representatives can be effective; that masses of letters, e-mails, cards, etc. get weighed rather than evaluated. 2. That Senator Voinovich maintains his vow to block mandating social security for public employees; that Peter R. Orszag, President Obama's budget director, has some years ago declared mandating social security for public employees was a "no brainer." We lose Voinovich in two years. 3. Bierdeman made it clear that STRS and its allies in the important pension lobbying groups are engaged in the complex issues facing pension systems making sure that if we need to act, we'll get the information and direction we need to act quickly and effectively. There are three organizations with which STRS is involved that provide extensive research and position papers about pension issues and efforts. They are: The National Council on Teacher Retirement (NCTR), <a href="www.nctr.org">www.nctr.org</a>; The National Association of State Retirement Administrators (NASRA), <a href="www.nctr.org">www.nctr.org</a>; and the Council of Institutional Investors (CII), <a href="www.cii.org">www.cii.org</a>.

#### In Memoriam

#### **VERA SMITH**

Vera Louise Smith, of Athens, passed away on Friday May 29, 2009, at her home with her family after a sudden fatal illness.

She married Robert Dean Smith on June 26, 1955 and moved to Athens in September of that year. A graduate of Kearney State College with a BFA in Music Education, she taught music in a number of area schools culminating in a 20-year position as music and choir director for Athens Middle School and High School. She was always willing to contribute her time and boundless energy to anything involving music. She held offices in and was an important contributor to a number of professional and community organizations relating to her career. Some of her projects included helping with music programs at Meigs Middle School, directing The Ohio Honors Chorale; directing the Athens Renaissance Singers, playing tenor recorder in the Athens Recorder Consort and singing in the OU Choral Union in addition to a number of church choirs over the years.

She is survived by her husband, a daughter, two sons and their spouses, 8 grandchildren, and 2 brothers.

#### **CURRENT NEWS OF EMERITI**

Professor Emeritus Bruce Ergood has just returned from south eastern Honduras where for the past three months he and his wife, Jane, have introduced a successful - and sustainable - egg producing program in six mountain villages. Bruce has been a volunteer with the Episcopal Church there since hurricane Mitch (1998) and when offered a teaching position at the Escuela Agricola Panamericana in Zamorano realized that he could combine the teaching with the work they were doing training and sustaining rural health workers.. .As a Latinamericanist with work experience in Mexico, Argentina, Ecuador, Belize, and Honduras, he was able to present information useful to a bi-lingual international group of students studying agriculture and food production. Zamorano, as this university is commonly called, is the largest agricultural college in Central America, serving students from over 12 countries. Its beautiful campus is located 29 km east of Tegucigalpa, the nation's capital, where it trains over 500 hundred students in animal and food science and research. Ergood taught in a relatively new career major: Socio-economic Development and Environment, and has been invited to return next winter. "It is a stimulating challenge to teach here," he commented, "but it certainly helps when you can speak Spanish."

At the Russ College of Engineering and Technology Spring Awards Banquet, <u>Joe Essman</u> was honored with a special surprise award from TEAMS - JETS in appreciation of his having helped over 200,000 high school students experience engineering.
