Dr. Pam Benoit

Executive Vice President and Provost

(Introduced by Dru Riley Evarts)



Pam Benoit joined Ohio University on July 1, 2009, as Executive Vice President and Provost. Dr. Benoit brought to Ohio University 20 years of experience as an educator, a scholar of communication, and an administrator charged with improving quality and accessibility.

Following the receipt of an MA in Communication from Central Michigan University and a PhD in Communication from Wayne State University, Dr. Benoit joined the faculty at Bowling Green State University. In 1984 she accepted a position in the Department of Communication at the University of Missouri-Columbia.

She has authored or co-authored a number of books, book chapters, articles and reports, and has been the recipient of many awards.

In 2006 she became the Vice Provost for Advanced Studies and Dean of the Graduate School at Missouri and made substantive contributions to the university's success in the areas of enrollment management; diversity; program review; economic development; recruitment of students, faculty and staff; and strategic planning. In each of her administrative positions, Dr. Benoit, who is a trained mediator, was actively involved in resolving conflicts and providing conflict resolution assistance to students and faculty through grievance and appeals panels, targeted programming, and campus mediation services.

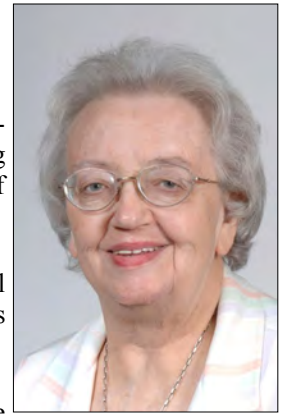

Notes on "Leadership in the Minority" June's luncheon presentation by Debbie Phillips

Although Democratic candidates to the Ohio House of Representatives received 150,000 more votes statewide than Republicans in the last election, gerrymandering has resulted in Democrats being at a 60-39 disadvantage. This would be less of a problem were it not for the hyper-partisanship that has developed in politics at both the state and national levels. On some issues, such as early childhood education, we can take a pragmatic approach and work together. But on others, no.

Part of the problem is that people don't really know what is going on in Columbus. They are more aware of national politics and local politics, a situation that can be frustrating.

Among the current issues in Columbus: K-12 education, rural Appalachia needs more money. There is a huge voucher expansion in the budget as well as opportunities for expansion of charter schools and their use of on-line technical education. There is a continuing decline of support for local government. Planned Parenthood is effectively defunded.

Distinguished Service Awards given last June

Catherine Brown and Joe Tucker were recognized with Distinguished Service Awards during the final academic year Emeriti meeting last June.

Brown had been president of the Emeriti Association in 2000-01 and 2001-02. Before that time she had served on the Constitution and By-laws Committee and the Program Committee. She was vice president and program chair for 1999-2000. After her presidency, she served as chair of the International Committee for three years and elections chair for one. Her award was given posthumously.

Tucker succeeded Brown as president, serving in that office for 2003-04 and 2004-05. Preceding that, he had been vice president and program chair for two years. After his presidency, he served as Emeriti Park chair for three years. He and his wife Jan still work with the Wednesday morning weeding and trimming group of emeriti who tend to the park Spring through Fall of each year.

BENEFITS REPORT

Things are quiet on the benefits front since the Legislature is not in session and OCHER does not meet in the summer. Return on the pension investment account for the recently ended fiscal year was 13.7%, well above the 7.75% standard recently set by legislative action but a little below benchmark pension systems. STRS administrative expenses were below budget.

AUREA G. KEYES, 89, of Boca Raton, FL died peacefully May 14, 2013. She began her career as a fashion stylist, continued in the photography business, then went on to enjoy success as a visual artist. While in Athens, she volunteered at the Trisolini Gallery and the Dairy Barn, and sat on the board of the Athens Children's Theater. She was an avid golfer.

Aurea is survived by her husband, Daniel Keyes, and 2 daughters.

JAMES M. WHITE, 86, died July 29, 2013, at Abbyshire Place in Gallipolis. He received his B.S. in electrical engineering from Ohio University in 1962. He retired from OU in 1989, where he taught electrical engineering, constructed the structures on Radar Hill, was director of utilities and assistant director of the physical plant. He also operated Jim White Contracting, where he repaired and remodeled homes.



Jim is survived by his wife of 55 years, Marie, a son & daughter-in-law, and 1 grandson.

JULIA C. LIN, 85, died in New York City August 1, 2013. She married Henry Lin and in 1959; they moved to Athens where Henry started the ceramics program and later became dean of the Fine Arts College. Julia became a professor of English. She had received an MA in English from the University of Washington in 1952 and in 1965 a PhD in Chinese Language and Literature.



Her husband, Henry Lin, passed away in 1989. She is survived by her daughter, Maya (who created the Vietnam Veterans Memorial), a son, Tan, and 3 grandchildren.

JAMES H. CONOVER, 83, passed away in Columbus, OH, on August 12, 2013. He taught for a while at Grinnell College in Iowa, but spent most of his career at Ohio University as professor and associate dean of fine arts, retiring in 1986. A playwright and author himself, he was a frequent director of OU's School of Theater productions and OVST Summer Theater productions.



Jim was married for 53 years to his late wife, Helen. He is survived by his wife of 3 years, Sylvia Abbott, a son, a daughter, and 4 grandchildren.
