TAKING OHIO TO THE 10-POINT SCALE, 10 MONTHS IN Jason Pina Introduced by Edward Baum



Jason Pina joined Ohio University in 2016 as the vice president for student affairs. He works to advance the intellectual and personal development of students. His purview includes 420+ professional and graduate-level staff, 3,200+ undergraduate student employees and an annual operating budget of \$127 million. Through the work of 11 departments, the division helps students get involved, grow as leaders, and find their niches as members of the Bobcat family.

Since his arrival here Dr. Pina has taken steps to ensure that the division will play an increasingly integral role in supporting student success. Last July, he helped to integrate the Survivor Advocacy Program into the division. In January he spearheaded the addition of Culinary Services, Bobcat Depot, and Regional Campus Retail Operations. He also helped to facilitate the launch of a new United Meditation Room as well as a new student scholarship, which is helping to address college affordability for deserving student employees.

Dr. Pina holds a doctoral degree from Johnson & Wales University, master's and educational specialist's degrees from the University of Northern Colorado, and a bachelor's degree in economics from Occidental College. His research interests include diversity and social justice, presidential leadership, and leadership development. He coedited AVP: Leading From the Unique Role of Associate/Assistant Vice President for Student Affairs. He currently serves on NASPA's James Scott Academy Board, a set of national thought leaders in student affairs. Dr. Pina resides in Athens with his wife, Shai, and their children, Myles and Kayla. Kayla is a first-year Bobcat and a Margaret Boyd Scholar majoring in chemical engineering.

As Professor Higgins sings, "I've grown accustomed to [their faces]." We are going through global warming. Our February spring should go a long way to call attention to its impact on icebergs, oceanic water levels, and huge storms. Seasonal aberrations are just one of the many effects of it. #### Notes on the March Luncheon Presentation by Keith Morrow WILDLIFE WE LIVE WITH—Yesterday, Today, and Tomorrow

To survive all animals need food, water, shelter, and biology. The arrival of man in Ohio tremendously affected wildlife. In 1700 95% of Ohio was forested and wildlife included bison, elk, gray wolves, and mountain lions. By 1900 only 10% of Ohio remained in forest and these, and other animals had disappeared. Since 1990 there has been a conscious attempt to foster wildlife including turkeys and even bears.

### **OCHER March Meeting**

The March 21 quarterly meeting of OCHER (Ohio Council of Higher Education Retirees) contained some good news and some bad news for OU emeriti. First, the bad news: the STRS Board has lowered the assumed rate of annual investment return to 7.45 from 7.75 percent, and also added several billion dollars to estimated unfunded liabilities by acknowledging that retirees are living longer than assumed by current life expectancy tables. So now the pension fund is only 60-65 percent funded, instead of the roughly 70 percent previously assumed. Upshot: at its April meeting, the STRS Board *is almost certainly* going to cut costs by restricting cost of living benefit increases—by how much and for how long are the only real questions.

But there were four pieces of good news. First, STRS health care costs have been rising less this year than projections. Second, this increases the likelihood that there will be few if any negative changes in health care benefits in 2018, although longer term some changes are likely coming that might particularly adversely impact those retiring before they reach Medicare eligibility. Third, so far this fiscal year, the STRS retirement system has earned over a nine percent return on investments, helping a bit in restoring the depleted pension fund. Last, for those on PERS, the news is all good. PERS is much better funded than STRS, and on the way towards full funding of pensions, despite, like STRS, reducing the assumed rate of return on investments.

## **IN MEMORIAM**

**Margret Appel**, age 70, passed away in her home in Camarillo, California on November 8th, 2016. She was born in Germany and resided in Athens for most of her adult life until she retired from Ohio University in 2007. Margret was the only child of Karl and Elfriede Appel who preceded her in death in 2015.

Dr. Appel joined the psychology faculty at Ohio University in 1971 after obtaining her doctoral degree from the University of Denver. Her professional background was in developmental psychology and infant psychophysiology.

In addition to her steadfast service to the Department of Psychology, Dr. Appel supported the university community with service on Faculty Senate, chairing both Faculty Senate and the University's Curriculum Council.

In addition to teaching courses at Ohio University throughout her four-decade career, she also taught regularly for Ohio University's program in Hong Kong. After her retirement, Dr. Appel enjoyed her time with her parents in California, volunteered at a local treatment facility for adolescent girls, maintained her avid interest in gardening, and continued her lifelong passion for traveling the world.

Both work closely with the Ohio Council of Higher Education Retirees (OCHER) ... representing all retirees from all 13 of Ohio's four-year state universities."
