Vice President Scott Moody reports that the Emeriti Association program for February 20 will be by **Matthew R. Shaftel**, Dean of the College of Fine Arts.



Dr. Shaftel has focused on helping Ohio to share and develop its distinctive role in the Arts and community transformation in the region, state, and well beyond. He has previously served as Dean of the Westminster College of the Arts at Rider University and the administrator of the Princeton campus, which included the Grammy award winning Westminster Choir College. Shaftel also served as Associate Vice President of Academic Affairs at Florida State University, where he led the development of a signature general-education program, *Liberal Studies for the 21st Century*. He received three degrees from Yale University.

Highly active as a teacher, scholar, and musician, he has won three university-wide teaching awards and was a quarter finalist for two national awards. Dr. Shaftel has published numerous articles and books, including a textbook published by Oxford University Press. His award-winning volume on

Cole Porter, coedited with Susan Weiss and Don Randel, was released in 2016 by the University of Illinois Press, and a volume on opera is forthcoming from Oxford University Press.

OCHER and Retirement System update, reported by Rosemary Rossiter

OPERS and STRS Report

January 16, 2020

The last OCHER meeting was in November 2019 and the next meeting will be in March 2020. The following comments are from materials posted on the STRS website.

OPERS:

Consistent with what was reported at the November OCHER meeting, OPERS has requested a 2-yr freeze on COLA's. Unlike the procedure at STRS, this request to freeze COLA's must be approved by the Ohio legislature. Also OPERS will cut allowances for Medicare-eligible retirees and make non-eligible retirees go to the ACA marketplace.

STRS:

2020 will mark the 100-yr anniversary of the establishment of STRS, which was the country's first public pension of its type.

On Jan 15 and 16 there will be closed meetings of the executive director search committee. The current executive director will retire at the end of June 2020.

An audit of 2019 financial reporting gave STRS a clean opinion. It was also noted that 5-yr returns put STRS among the top 25 public funds. Another consultant reported that investment costs for STRS (payments for managing the fund) are the 2nd lowest about 17 peers, primarily due to 70% of activity being managed in-house.

Annual nominal returns for 2019 was 7.13%, which is below the 7.45% assumed return and below 2018 returns. Returns by asset class are as follows:

Domestic equities 8.74% International equities 2.85% Bonds 7.65% Real estate 7.6% Alternative investments 8.3%
