# DEAN, SCHOOL OF HEALTH PROFESSIONS

New York Institute of Technology (NYIT) is seeking an energetic, innovative thought leader to serve as dean of the School of Health Professions. As the school's chief academic and administrative officer, the dean will provide the vision, leadership, and creativity along with specific strategies and effective administrative and fiscal management—to lead the school to its next level of excellence in the areas of inter-professional education, program development, grant acquisition and management, alumni outreach, and community-based initiatives.

NYIT's School of Health Professions, together with NYIT College of Osteopathic Medicine, NYIT's Academic Healthcare Center, and affiliated major teaching hospitals, constitute one of about 100 academic health centers in the U.S. that provide leadership for health professions education, patient care, and biomedical and health services research. As chief academic officer of the school, the dean will report to the Vice President for Medical Affairs and Global Health and be responsible for developing, leading, and implementing strategic planning with faculty and staff; overseeing curriculum and academic programming; supervising staff and faculty; overseeing school budget and enrollment activity planning; and leading external and internal communications about the school. He or she will:

- Engage regularly and directly with students and staff across the university.
- Identify, nurture, and help implement new health profession projects and programs.
- Maintain current program-specific accreditations.
- Identify and pursue external funding for health profession projects.

- Doctoral degree in a relevant field from an accredited institution.
- Record of excellence in teaching, scholarship, and professional activity to meet the qualifications required for the assignment of faculty rank of tenured Professor.
- Experience with and support for educational technology, and multidisciplinary collaboration.
- Minimum of 5 years of successful administrative experience, including strategic planning and visioning, and leading organizational change at a senior administrative level in an academic setting.
- Experience in design, development, and delivery of collaborative professional programs, and development of a collaborative culture.
- Demonstrated ability to work with a diverse range of internal and external partners to build successful programs.
- Knowledge of higher education budgeting, planning, personnel, and curricular assessment processes.
- Excellent communication, teamwork, consensus building, and organizational skills.
