



The Fashion School NYC Studio Summer Session 2011 June 6 – July 29

The NYC Studio, part of The Fashion School at Kent State, provides fashion students (or those interested in fashion studies) the opportunity for summer study in the fashion capital of the world. Classes are held in the heart of New York City's Fashion District. The intensive 8-week session is taught by industry professionals. The KSU NYC Studio staff is experienced and knowledgeable in supporting student needs.

Eligibility:

In order to participate, students must be in good academic standing at their home school and must have a minimum 2.5 cumulative GPA upon application. All students must complete and submit the Program Application and \$750 non-refundable, non-transferable program fee to hold a spot in the program.

Course Offerings and Requirements:

Students may earn 6-12 semester credits. All NYC Studio participants are required to ***maintain enrollment in at least 6 credit hours.***

The only REQUIRED course while enrolled at the KSU NYC Studio is the NY Study Tour (3 credits).
